Terms and Conditions of Sale

1. Simpson Performance Products will offer the customer a ninety (90) day, three (3) payment programs with no finance charges on any order over \$500.00 and up to \$1500.00. Orders over \$1500.00 will be subject to credit approval.
2. The customer agrees to purchase the safety product and make a one-half (1/2) initial payment to Simpson plus any applicable shipping charges and taxes. Sixty (60) days after the initial purchase date the customer makes a second one-fourth (1/4) payment and to complete the transaction, ninety (90) days after the purchase date the customer makes a final one-fourth payment to Simpson.
3. The customer must purchase the products with a major credit card (Visa, Master Card, American Express or Discover) and agree to allow Simpson to make two (2) additional charges to the card for equal amounts for the remaining balance of the purchase on the second and third payments days (sixty (60) and ninety (90) days from the date of purchase). This will be an auto-transaction process and each charge will appear on the customer's monthly statement on the corresponding billing month.
4. The customer will be charged a fifty dollar (\$50.00) service fee and a 1.5% monthly interest fee for any credit card charge that is not accepted due to an invalidated credit card status at the time of billing.
5. This program is at the complete discretion of Simpson Performance Products and Simpson reserves the right to limit its implementation and to cancel the program without notice.
